



NATURAL GAS CHOICE SUPPLY AGREEMENT

This Agreement made and entered into **January 14, 2026**, by and between WRW Energy, at 10123 Alliance Road, Cincinnati, OH 45242 hereinafter referred to as "Seller" and **ABC COMPANY, LLC** hereinafter referred to as "Buyer", at **440 W 140TH ST, CLEVELAND, OH 44135**. Buyer is a customer of Enbridge Gas Ohio, "EGO" (formerly Dominion Energy).

AGREEMENT. Subject to acceptance by Seller and EGO, Seller shall sell and deliver, and Buyer shall purchase, 100% of Buyer's natural gas requirements for the service location identified above. Buyer may request, at no charge, up to twenty-four (24) months of Seller billing/payment history.

BILLING AND PAYMENT. EGO will issue a single monthly consolidated bill including EGO delivery charges, riders, taxes/fees assessed by EGO, Seller's commodity charges, and applicable sales tax. Tax-exempt Buyers must provide a valid Ohio exemption certificate. Nonpayment may result in disconnection by EGO in accordance with its tariff and applicable PUCO regulations. Seller may terminate this Agreement consistent with PUCO rules and EGO procedures.

PRICE & TERM. Initial term: **month-to-month**.

Price: **Enbridge MRR rate (as posted by the utility) minus \$0.50** of natural gas commodity, exclusive of EGO delivery charges, riders, taxes, and governmental fees. Volumes will be billed using EGO meter readings and applicable BTU conversion factors.

TERM & RENEWAL. Effective from the **March 2026** billing cycle and is **effective until cancelled by either party**. Seller will provide renewal notice by mail in accordance with PUCO rules. Unless cancelled in writing by either party, the Agreement will continue month-to-month at Seller's then-current variable market rate, which may change monthly. EGO will send an enrollment confirmation. Buyer may rescind without penalty within seven (7) business days after the postmark of EGO's confirmation by contacting EGO at 800-362-7557 or in writing. No early termination fees apply.

FORCE MAJEURE. Neither party shall be deemed in default for failure to perform due to Force Majeure events beyond its reasonable control, except payment obligations. Nothing herein supersedes EGO's tariff or applicable PUCO regulations, which govern in the event of any inconsistency.

BURNERTIP VOLUMES (estimated): **2,164.8** Mcf

TERMINATION/TRANSFER. If Buyer relocates outside EGO's service area or contract portability area, this Agreement terminates without penalty. If Buyer relocates within EGO's service area, the Agreement continues at the new location. Switching fees, if any, apply per EGO's tariff. Buyer agrees to advise Seller of relocation and authorizes EGO to provide Seller with account number and meter number of new location. If Buyer voluntarily returns to EGO sales service after choosing a natural gas supplier, Buyer may be charged a price other than EGO's regulated sales service rate.
